Admission Policy of Holy Family Junior School

1. Introduction

This Admission Policy complies with the requirements of the Education Act 1998, the

Education (Admission to Schools) Act 2018 and the Equal Status Act 2000. In drafting this

policy, the board of management of the school has consulted with school staff, the school

patron and with parents of children attending the school.

The policy was approved by the school patron in November 2023. It is published on the

school's website and will be made available in hardcopy, on request, to any person who

requests it.

The relevant dates and timelines for Holy Family Junior School admission process are set out

in the Ennis school's common admission notice which is published annually on the school's

website at least one week before the commencement of the admission process for the school

year concerned.

This policy must be read in conjunction with the annual admission notice for the school year

concerned.

The application form for admission is published on the school's website and will be made available in hardcopy on request to any person who requests it.

2. Characteristic spirit and general objectives of the school

Holy Family Junior School is a Catholic co-educational primary school with a Catholic ethos under the patronage of the Bishop of Killaloe.

"Catholic Ethos" in the context of a Catholic primary school means the ethos and characteristic spirit of the Roman Catholic Church, which aims at promoting:

- (a) the full and harmonious development of all aspects of the person of the pupil, a living relationship with God and with other people; and
- (b) including the intellectual, physical, cultural, moral and spiritual aspects; and
- (c) a philosophy of life inspired by belief in God and in the life, death and resurrection of Jesus; and
- (d) the formation of the pupils in the Catholic faith; and which school provides religious education for the pupils in accordance with the doctrines, practices and traditions of the Roman Catholic Church, and/or such ethos and/or characteristic spirit as may be determined or interpreted from time to time by the Irish Episcopal Conference.

In accordance with S.15 (2) (b) of the Education Act, 1998 the Board of Management of Holy Family Junior School shall uphold, and be accountable to the patron for so upholding, the characteristic spirit of the school as determined by the cultural, educational, moral, religious, social, linguistic and spiritual values and traditions which inform and are characteristic of the objectives and conduct of the school.

Holy Family Junior School is founded upon Gospel values and our Catholic tradition. The staff of Holy Family Junior School want to create a climate of physical, emotional, social, and intellectual safety for students, teachers and parents so that teaching and learning can occur within relationships of mutual valuing and respect.

With this in mind, the teachers of the school see education not just as providing students with knowledge and skills but also as providing for the emotional, social, sexual, physical and spiritual development of students.

In this school we want students to be self-motivated and to be at peace with themselves, others and the world. Achievement of these aspirations by the school requires the help and cooperation of students, teachers and parents.

3. Admission Statement

Holy Family Junior School will not discriminate in its admission of a student to the school on any of the following:

- (a) the gender ground of the student or the applicant in respect of the student concerned,
- (b) the civil status ground of the student or the applicant in respect of the student concerned,
- (c) the family status ground of the student or the applicant in respect of the student concerned.
- (d) the sexual orientation ground of the student or the applicant in respect of the student concerned,
- (e) the religion ground of the student or the applicant in respect of the student concerned,
- (f) the disability ground of the student or the applicant in respect of the student concerned,
- (g) the ground of race of the student or the applicant in respect of the student concerned,
- (h) the Traveller community ground of the student or the applicant in respect of the student concerned, or
- (i) the ground that the student or the applicant in respect of the student concerned has special educational needs
- (j) Schools with special education classes Holy Family Junior School is a school which has two established special classes, with the approval of the Minister for Education and Skills, which provides an education exclusively for students with a category or categories of special educational needs

specified by the Minister and may refuse to admit to the class a student who does not have the category of needs specified.

As per section 61 (3) of the Education Act 1998, 'civil status ground', 'disability ground', 'discriminate', 'family status ground', 'gender ground', 'ground of race', 'religion ground', 'sexual orientation ground' and 'Traveller community ground' shall be construed in accordance with section 3 of the Equal Status Act 2000.

Holy Family Junior School will cooperate with the National Council for Special Education in the performance by the Council of its functions under the Education for Persons with Special Educational Needs Act 2004 relating to the provision of education to children with special educational needs, including in particular by the provision and operation of a special class or classes when requested to do so by the Council.

Holy Family Junior School will comply with any direction served on the patron or the board, as the case may be, under section 37A and any direction served on the board under section 67(4B) of the Education Act.

All denominational schools

Holy Family Junior School is a school whose objective is to provide education in an environment which promotes certain religious values and does not discriminate where it refuses to admit as a student a person who is not of the Catholic faith and it is proved that the refusal is essential to maintain the ethos of the school.

Note for Parents: the inclusion of the above wording was mandated by the Education (Admission to Schools) Act 2018.

Although obliged by the state to include the above statement, Holy Family Junior School has never refused admission to any child on these grounds and does not envisage ever doing so, as to do so would be contrary to the Catholic ethos of the school.

4. Categories of Special Educational Needs catered for in the school/special class

Holy Family Junior School, with the approval of the Minister for Education and Skills, has established classes to provide an education exclusively for students with Developmental language Delay, and for students with Autism.

5. Admission of Students

This school shall admit each student seeking admission except where –

- a) the school is oversubscribed (please see section 6 below for further details)
- b) a parent of a student, when required by the principal in accordance with section 23(4) of the Education (Welfare) Act 2000, fails to confirm in writing that the code of behaviour of the school is acceptable to him or her and that he or she shall make all reasonable efforts to ensure compliance with such code by the student.

c) Special classes

The special classes attached to Holy Family Junior School provides an education exclusively for students with Developmental Language Disorder, and for students with Autism. The school may refuse admission to these classes, where the student concerned does not have the specified category of special educational needs provided for in these classes.

6. Oversubscription

In the event that the school is oversubscribed, the school will, when deciding on applications for admission, apply the following selection criteria in the order listed below to those applications that are received within the timeline for receipt of applications as set out in the school's annual admission notice:

1. Siblings and Staff

On an equal basis, applicants with siblings currently enrolled in the school (including stepsiblings, resident at the same address) and children of school staff, priority eldest;

2. Parish

- **a.** Children residing in the parish and who are 1.5km or less in walking distance from the school, priority eldest; This will be measured by Google maps, using Eircode to Eircode walking distance.
- b. All other children residing in the parish, priority eldest.
- 3. Past pupils

Children and or siblings of past pupils, priority eldest;

4. Others

All other applicants, priority eldest.

Please note, a copy of a utility bill may be asked for as proof of address.

In the event that there are two or more students tied for a place or places in any of the selection criteria categories above (the number of applicants exceeds the number of remaining places), the following arrangements will apply:

They will be arranged in order of age, priority eldest.

If born on the same day, then by lottery.

7. What will not be considered or taken into account

In accordance with section 62(7)(e) of the Education Act, the school will not consider or take into account any of the following in deciding on applications for admission or when placing a student on a waiting list for admission to the school:

- (a) a student's prior attendance at a pre-school or pre-school service
- (b) the payment of fees or contributions (howsoever described) to the school;
- (c) a student's academic ability, skills or aptitude;
- (d) the occupation, financial status, academic ability, skills or aptitude of a student's parents;
- (e) a requirement that a student, or his or her parents, attend an interview, open day or other meeting as a condition of admission;
- (f) a student's connection to the school by virtue of a member of his or her family attending or having previously attended the school;
- (g) a student's connection to the school by virtue of a member of his or her family attending or having previously attended the school;
 - (other than, in the case of the school wishing to include a selection criteria based on
 - (1) siblings of a student attending or having attended the school and/or (2) parents or grandparents of a student having attended the school.
 - In relation to (2) parents and grandparents having attended, a school may only apply these criteria to a maximum of 25% of the available spaces as set out in the school's annual admission notice).
- (h) the date and time on which an application for admission was received by the school, This is subject to the application being received at any time during the period specified for receiving applications set out in the annual admission notice of the school for the school year concerned.

This is also subject to the school making offers based on existing waiting lists (up until 31st January 2025 only).

8. Decisions on applications

All decisions on applications for admission to Holy Family Junior School will be based on the following:

- Our school's admission policy
- The school's annual admission notice (where applicable)
- The information provided by the applicant in the school's official application form received during the period specified in our annual admission notice for receiving applications

(Please see <u>section 15</u> below in relation to applications received outside of the admissions period and <u>section 16</u> below in relation to applications for places in years other than the intake group.)

Selection criteria that are not included in our school admission policy will not be used to make a decision on an application for a place in our school.

9. Notifying applicants of decisions

Applicants will be informed in writing as to the decision of the school, within the timeline outlined in the annual admissions notice.

If a student is not offered a place in our school, the reasons why they were not offered a place will be communicated in writing to the applicant, including, where applicable, details of the student's ranking against the selection criteria and details of the student's place on the waiting list for the school year concerned.

Applicants will be informed of the right to seek a review/right of appeal of the school's decision (see <u>section 18</u> below for further details).

10. Acceptance of an offer of a place by an applicant

In accepting an offer of admission from Holy Family Junior School, you must indicate—

- (i) whether or not you have accepted an offer of admission for another school or schools. If you have accepted such an offer, you must also provide details of the offer or offers concerned and
- (ii) whether or not you have applied for and awaiting confirmation of an offer of admission from another school or schools, and if so, you must provide details of the other school or schools concerned.

11. Circumstances in which offers may not be made or may be withdrawn

An offer of admission may not be made or may be withdrawn by Holy Family Junior School where—

- (i) it is established that information contained in the application is false or misleading.
- (ii) an applicant fails to confirm acceptance of an offer of admission on or before the date set out in the annual admission notice of the school.
- (iii) the parent of a student, when required by the principal in accordance with section 23(4) of the Education (Welfare) Act 2000, fails to confirm in writing that the code of behaviour of the school is acceptable to him or her and that he or she shall make all reasonable efforts to ensure compliance with such code by the student; or
- (iv) an applicant has failed to comply with the requirements of 'acceptance of an offer' as set out in section 10 above.

12. Sharing of Data with other schools

Applicants should be aware that section 66(6) of the Education (Admission to Schools) Act 2018 allows for the sharing of certain information between schools in order to facilitate the efficient admission of students.

Section 66(6) allows a school to provide a patron or another board of management with a list of the students in relation to whom—

- (i) an application for admission to the school has been received,
- (ii) an offer of admission to the school has been made, or
- (iii) an offer of admission to the school has been accepted.

The list may include any or all of the following:

- (i) the date on which an application for admission was received by the school;
- (ii) the date on which an offer of admission was made by the school;
- (iii) the date on which an offer of admission was accepted by an applicant;
- (iv) a student's personal details including his or her name, address, date of birth and personal public service number (within the meaning of section 262 of the Social Welfare Consolidation Act 2005).

13. Waiting list in the event of oversubscription

In the event of there being more applications to the school year concerned than places available, a waiting list of students whose applications for admission to Holy Family Junior School were unsuccessful due to the school being oversubscribed will be compiled and will remain valid for the school year in which admission is being sought.

Placement on the waiting list of Holy Family Junior School is in the order of priority assigned to the students' applications after the school has applied the selection criteria in accordance with this admission policy.

Applicants whose applications are received after the closing date, outlined in the Annual Admission Notice, will be placed at the end of the waiting list in order of the date of receipt of the application.

Offers of any subsequent places that become available for and during the school year in relation to which admission is being sought will be made to those students on the waiting list, in accordance with the order of priority in relation to which the students have been placed on the list.

14. Late Applications

All applications for admission received after the closing date as outlined in the annual admission notice will be considered and decided upon in accordance with our school's admissions policy, the Education Admissions to School Act 2018 and any regulations made under that Act.

Late applicants will be notified of the decision in respect of their application no later than three weeks after the date on which the school received the application. Late applicants will be offered a place if there is place available. In the event that there is no place available, the name of the applicant will be added to the waiting list as set out in Section 13.

15. Procedures for admission of students to other years and during the school year Applications for enrolment during the school year will be considered subject to school policy, enrolment cap, available space and the provision of information concerning attendance and the child's educational progress.

Such applications will be considered on a case by case basis and will normally only be considered for admission on the first day of each new term unless the applicant is newly resident in the area.

Applications to enrol into classes other than Junior Infants intake may be received by the school at any time during the year. In the event that the school is full or the Junior Infants intake procedure has not yet been addressed, then the parents will be informed of the situation and the student will be placed on a transfer list (if an application to enrol is

received). This list is populated in chronological order of receipt of application to enrol (stamped with the date of receipt in the office).

When a place becomes available in the school, and the Junior Infant intake procedure has been addressed, then it will be offered to applicants on the transfer list in order.

16. Declaration in relation to the non-charging of fees

This rule applies to <u>all</u> schools.

The board of Holy Family Junior School or any persons acting on its behalf will not charge fees for or seek payment or contributions (howsoever described) as a condition of-

- (a) an application for admission of a student to the school, or
- (b) the admission or continued enrolment of a student in the school.

17. Arrangements regarding students not attending religious instruction

This section must be completed by schools that provide religious instruction to students.

The following are the school's arrangements for students, where the parents, who have requested that the student attend the school without attending religious instruction in the school. These arrangements will not result in a reduction in the school day of such students:

Pupils will remain in the classroom but will not participate in religious instruction and will be given another activity while religious instruction takes place.

In the case of religious services in school, non-participating pupils will be provided with supervision in another classroom for the duration.

18. Reviews/appeals

Review of decisions by the board of Management

The parent of the student may request the board to review a decision to refuse admission. Such requests must be made in accordance with Section 29C of the Education Act 1998.

The timeline within which such a review must be requested and the other requirements applicable to such reviews are set out in the procedures determined by the Minister under section 29B of the Education Act 1998 which are published on the website of the Department of Education and Skills.

The board will conduct such reviews in accordance with the requirements of the procedures determined under Section 29B and with section 29C of the Education Act 1998.

Note: Where an applicant has been refused admission due to the school being oversubscribed, the applicant <u>must request a review</u> of that decision by the board of management prior to making an appeal under section 29 of the Education Act 1998.

Where an applicant has been refused admission due to a reason other than the school being oversubscribed, the applicant <u>may request a review</u> of that decision by the board of management prior to making an appeal under section 29 of the Education Act 1998.

Right of appeal

Under Section 29 of the Education Act 1998, the parent of the student, or in the case of a student who has reached the age of 18 years, the student, may appeal a decision of this school to refuse admission.

An appeal may be made under Section 29 (1)(c)(i) of the Education Act 1998 where the refusal to admit was due to the school being oversubscribed.

An appeal may be made under Section 29 (1)(c)(ii) of the Education Act 1998 where the refusal to admit was due a reason other than the school being oversubscribed.

Where an applicant has been refused admission due to the school being oversubscribed, the applicant <u>must request a review</u> of that decision by the board of management <u>prior to</u>

<u>making an appeal</u> under section 29 of the Education Act 1998. (see Review of decisions by the Board of Management)

Where an applicant has been refused admission due to a reason other than the school being oversubscribed, the applicant <u>may request a review</u> of that decision by the board of management prior to making an appeal under section 29 of the Education Act 1998. (see Review of decisions by the Board of Management)

Appeals under Section 29 of the Education Act 1998 will be considered and determined by an independent appeals committee appointed by the Minister for Education and Skills.

The timeline within which such an appeal must be made and the other requirements applicable to such appeals are set out in the procedures determined by the Minister under section 29B of the Education Act 1998 which are published on the website of the Department of Education and Skills.

Special Class for Autism

Admission Guidelines

November 2023

1. Introductory Statement

The decision to provide a Special Class for Autism was taken by the Board of Management in collaboration with the staff of Holy Family Junior School in 2017.

Holy Family Junior School is a mainstream, co-educational junior national school. It has a special class for Autism from Junior Infants to First Class. The class is currently staffed by a full-time teacher and two special needs assistants. The pupils are welcomed into a safe and nurturing environment, where every effort is made to meet their sensory, social, emotional and educational needs. Where appropriate, the pupils in the class are integrated with the other pupils at playtime and they are also timetabled for inclusion with a specific class group for subjects that they enjoy.

The school's admissions policy should be read in conjunction with this document which is specific to the Special Class for Autism.

2. Our Aims

Holy Family Junior School aspires to achieve the full potential of each child, and promotes openness and co-operation between staff, parents and pupils as a means towards providing the caring environment through which a child can develop and grow.

Our Special Class for Autism aims to offer an autism specific learning environment within a mainstream co-educational junior national school. This setting facilitates optimum inclusion as part of the school community with access to mainstream activities from junior infants to first class as appropriate.

3. Admission of pupils

The Special Class for Autism has places for a maximum of 6 pupils. The number of places available each September will be published on the school's annual admissions statement. The school shall only admit those pupils who meet the enrolment criteria. It may not be possible to admit all pupils who meet the enrolment criteria when:

- a) the class is oversubscribed (please see below 5 for further details)
- b) a parent of a pupil, when required by the principal in accordance with section 23(4) of the Education (Welfare) Act 2000, fails to confirm in writing that the positive code of behaviour of the school is acceptable to him or her and that he or she shall make all reasonable efforts to ensure compliance with such code by the pupil.

4. Enrolment Criteria

The criteria for enrolment to the class incorporating the Dept. of Education and H.S.E. policies are as follows:

- The child must have a diagnosis of Autism made using the DSM-IV or ICD 10.
- A recent report from a Psychologist/Psychiatrist or multi-disciplinary team of professionals should be provided. A multi-disciplinary team may consist of a Clinical Psychologist, an Occupational Therapist, a Speech & Language Therapist, a Social Worker and/or a Physiotherapist. Please note all reports on a child must accompany the application for admission. These reports will be considered by the school's admissions team.
- There must be a recommendation by the professionals in the report that a special class placement in a mainstream school is both necessary and suitable for the child.
- A copy of your child's birth certificate will be required for registration.

5. Oversubscription

If the Special Class for Autism is oversubscribed with pupils who all meet the enrolment criteria, pupils in the following order of categories will be given preference.

- a) Children already enrolled in Holy Family Junior School mainstream classes and their siblings
- b) Siblings of children enrolled in Holy Family Senior School (including step-siblings, resident at the same address).
- c) Children entering Junior Infants.
- d) Children living within Ennis parish.
- e) All other applicants.

Please note, a copy of a recent utility bill may be asked for as proof of address.

6. Enrolment Procedure

- 1. A parent/guardian may contact the Principal of the school to seek information about the special class for Autism in the school, by phoning 065 6829808.
- 2. Application forms for the Special Class for Autism can be obtained by phoning the school on 065 6829808, by emailing office@hfjs.ie or by writing to the Principal, Holy Family Junior School, Station Road, Ennis, Co. Clare. Receipt of acknowledgement of an enrolment application by the school does not constitute an offer of a place nor does it guarantee a place in the school.
- 3. The Class Admissions Team consists of the Principal, Special Class Teacher and a member of the SEN Team.
- 4. Each application will be considered by the Admissions Team. The Admissions Team may seek the advice of the school's allocated NEPS psychologist
- 5. The Admissions Team will meet during the last week of term 2 each year and will undertake to communicate to the parent/guardian their decision in writing within 21 days of this meeting.
- 6. Parents who are offered a place must complete and return our Special Class for Autism enrolment registration form within two weeks of the letter of offer to accept a placement. If the school does not receive the enrolment form within this time frame, the place will be offered to another child.
- 7. If spaces are still available in the class after this date the Admissions Team will reconvene a meeting at a later date to further assess applications.

7. Implementation and Review:

These admission guidelines for the Special Class for Autism will be reviewed at the end of every school year, or as circumstances require.
